Re: Three Simultaneous Vice & Narcotics Search Warrants in Hernando County

Nets Seven Arrests – 2024-0018301995

Date: June 21, 2024

On o6-21-2024, the Hernando County Sheriff's Office Vice and Narcotics Unit, with assistance from the Citrus County Sheriff's Office SWAT Team, Pasco Sheriff's Office Unmanned Systems Team (Drone Unit), and the HCSO SWAT Team, executed three simultaneous residential search warrants following several months of investigation.

This coordinated effort resulted in multiple arrests and significant seizures of illegal substances and firearms.
