Re: UPDATE # 1 - Possession of Child Pornography Arrest – Cameron Michael

Szada-Daubert –2023-09910

Date: October 28, 2024

On 10-18-2024, the Hernando County Sheriff's Office received information on the identities of two additional victims in a case involving the arrest of **Cameron Michael Szada-Daubert** on 03-28-2024 for Possession of Child Pornography.

With two additional victims now positively identified, Szada-Daubert DOB/03-14-2001 was charged with 13 counts of Showing Obscene Material to a Minor, 2 counts of Soliciting a Child for Unlawful Sexual Conduct using Computer Services or Devices, and two counts of Unlawful Use of a Two-Way Communication Device.

On 10-28-2023, a warrant was issued for Szada-Daubert's arrest on the charges listed above.

He was later arrested at a residence on Moale Road in Brooksville. He was transported to the Hernando County Detention Center where his bond was set at \$85,000.

## Original information

On 03-28-2023, Hernando County Sheriff's detectives received information regarding the possession of child pornography.

Subsequent investigation revealed a possible suspect, identified as **Cameron Michael Szada- Daubert**.

Detectives authored a search warrant for Szada-Daubert's online accounts. The search warrant was subsequently served to Szada-Daubert's social media provider. The search warrant yielded the contents of Szada-Daubert's account.

Upon reviewing the contents of **Szada-Daubert's** account, detectives located **4** files of Child Sexual Abuse Material (CSAM).

On 07-10-2023, detectives responded to Szada-Daubert's residence, located at 452 Moale Road in Brooksville to speak to him.

During the interview, **Szada-Daubert** was uncooperative with the investigation and no arrest was made at that time.

Additional investigation revealed **Szada-Daubert** created two separate online identities in an attempt to conceal his true identity. He used the two accounts to send and acquire nude images and videos of juveniles.

Investigators identified 13 accounts where **Szada-Daubert** was believed to be communicating with juveniles. Out of the 13 accounts, investigators were able to identify the owners of seven of the online accounts. Out of the seven who were identified, five were juvenile victims. Only three of the five victims agreed to assist law enforcement with its investigation.

Investigators are working to identify an additional two potential victims.

On 05-17-2024, **Szada-Daubert** was arrested after turning himself in at the Hernando County Detention Center.

Cameron Michael Szada-Daubert DOB/03-14-2001 was arrested and charged as follows:

- Possession of Child Pornography (4 counts)
- Show Obscene Material to a Minor (16 counts)
- Soliciting a Child for Unlawful Sexual Conduct using Computer Services (2 counts)
- Unlawful Use of a Two-Way Device (3 counts)
- No BOND.

The investigation continues.

Sheriff Al Nienhuis has a zero tolerance for possession of Child Sexual Abuse Material. Any and all tips are, and will be, meticulously investigated, no stone will be left unturned. Any person who possesses material of this nature will be prosecuted to the fullest extent of the law.
