Date: November 15, 2024

On 11-15-2024, the Hernando County Sheriff's Office Vice and Narcotics Unit executed a residential search warrant at 3251 Welsh Street in Spring Hill.

During the execution of the search warrant, a total of 11 people were located within the residence. Of the 11 subjects, 9 people were found to be in **possession of methamphetamine**, marijuana, and drug paraphernalia.

This is a culmination of several months of investigation into the use and distribution of methamphetamine within Hernando County. During the investigation, the Sheriff's Office seized trafficking amounts of methamphetamine coming from the property.
